EMPLOYMENT OF SUMMER SCHOOL STAFF</p> <p>The Board directs that summer school program employes will be qualified and competent to fulfill assignments in accordance with these guidelines.</p> <p>The Board shall approve the employment, fix the compensation and establish the period of employment for each person employed in the summer school program of this district, when said program of this district is authorized by the Board.</p> <p>Such approval shall normally be given to those candidates recommended by the Summer School Director and the Superintendent.</p> <p>Primary consideration will be given to candidates for summer school employment who are members of the staff of the school district.</p> <p>No candidate shall be employed until such candidate has complied with the mandatory background check requirements for criminal history and the district has evaluated the results of that screening process.</p> <p>Any employe's misstatement of fact material to qualifications for employment or the determination of salary shall be considered by this Board to constitute grounds for dismissal.</p> <p>The Superintendent shall develop procedures for the recruitment, screening and recommendation of candidates for summer school employment in accordance with the following guidelines:</p>	<p>SC 406 1146, 1901</p> <p>SC 111</p>
