## 912. RELATIONS WITH EDUCATIONAL INSTITUTIONS

1. Purpose

It is the policy of the Board that strong lines of communication be maintained by the **district with other districts and institutions which provide programs, training, or services not otherwise available to children residing in this district and with districts whose resident students are enrolled in programs of this district.**

2. Authority

The district **in which pupils are in attendance has responsibility and authority for said pupils. In order that those pupils receive maximum benefit from their program of studies, articulation between the cooperating institutions is essential.**

3. Delegation of Responsibility

**In order to maintain cordial and constructive relationships with other educational institutions. the Superintendent shall**

**(A. In the Case of a Receiving District)**

**inform the sending district of any serious discipline problems encountered with pupils from their district.**

**(B. In the Case of a Sending District)**

**keep the Board informed of any problems of an individual or group nature that may adversely affect the educational progress of the district's pupils.**

accordance with Board policy on student  
teachers.

honor all requests for transcripts and **other**  
records in accordance with the Board's policy on  
pupil records.
